INSTRUCTIONS

- A member desiring to exercise vote by Postal Ballot shall complete this Postal Ballot Form and send it duly and properly sealed to the Scrutinizer in the self-addressed business reply envelope sent herewith. However, envelopes containing Postal Ballot Form, if sent by courier or by registered post/speed post at the expense of the Member will also be accepted. Members are requested to convey their assent or dissent in this Postal Ballot Form only. Assent or dissent received in any other form or manner shall be considered as invalid.
- 2) This Form should be completed and signed by the member (as per the specimen signature registered with the Company / Depository Participant(s)). In case of Joint holding, this Form should be completed and signed by the first named member and in his absence, by the next named Member.
- 3) Duly completed Postal Ballot Form should reach the Scrutinizer not later than 5 P.M. on 9th August, 2017. All Postal Ballot forms received after this date will be strictly treated as if reply from such member(s) has not been received.
- 4) There will be only one Postal Ballot Form for every Folio No./ DP ID_Client ID irrespective of the number of Joint Member(s).

 On receipt of the duplicate Postal Ballot Form, the original will be rejected.
- 5) In case of shares held by Corporate/ Institutional members (i.e. other than individuals, HUF, NRI etc.) the duly completed Postal Ballot Form should be accompanied by a certified copy of Board Resolution / Authority Letter with attested specimen signatures of the duly authorised signatories.
- 6) Members are requested not to send any other paper along with the Postal Ballot Form in the enclosed self addressed business reply envelope, as all such envelopes will be sent to the Scrutinizer and any extraneous paper found in such envelope would be destroyed by the Scrutinizer.

- 8) Incomplete, unsigned or incorrect Postal Ballot Forms will be rejected. The Scrutinizer's decision on the validity of a Postal Ballot will be final and binding.
- 9) Additionally, please note that the Postal Ballot Form shall be considered invalid if:
 - a. A Form other than one issued by the Company has been used;
 - b. Signature on the Postal Ballot Form doesn't match with the specimen signature with the Company / Depository Participant;
 - c. It is not possible to determine without any doubt the assent or dissent of the Member;
 - d. Neither assent or dissent is mentioned;
 - e. Any competent authority has given directions in writing to the Company to freeze the voting rights of the Member;
 - f. The envelope containing the Postal Ballot Form is received after the last date prescribed;
 - g. The Postal Ballot Form signed in the representative capacity is not accompanied by a certified copy of the relevant specific authority;
 - h. It is defaced or mutilated in such a way that its identity as genuine Form cannot be established;
 - i. The member has made any amendment to the Resolution or imposed any condition while exercising his vote.
- 10) Voting rights shall be reckoned on the paid up value of shares registered in the name of the member(s) on Friday, 30th day of June, 2017 (cut-off date).
- 11) Voting by Postal Ballot or through e-voting may be exercised by the Members or its duly constituted attorney. Exercise of vote by Postal Ballot through Proxy is not permitted.
- 12) The Company is pleased to offer e-voting facility as an alternate, for all the Members of the Company to enable them to cast their votes electronically instead of returning duly filled-up Postal Ballot Form.
